Course Introduction	<p>This course aims to study the political, economic, and socio-cultural relations between Australia and other major countries in the Asia-Pacific region. The course will be conducted fully in English. It covers 5 parts: (1) Emergence of Australia and Changes in Foreign Relations ; (2) Australia and Giant Countries of U.S.A., China and Japan ; (3) Australia and East and Southeast Asia (esp. Indonesia) ; (4) Australia and the South Pacific ; (5) APEC and Australia as an Asia-Pacific Regional Power. (For details, check "Course List")</p>
