Course Introduction	<p>Pragmatics is the study of how we use language in context to communicate meanings and intentions. This seminar will explore principles, concepts and research methodologies of pragmatics with a focus on pedagogical implications on how teachers can foster pragmatic competence in the EFL classroom. Topics on theoretical framework will include speech acts, implicature (Gricean Maxims), politeness theory, and pragmatic inference and awareness. Participants will work on a class project collecting and analyzing original data as the basis for writing a term paper.</p>
