Course Introduction	<p>This course focuses on the diplomatic history of the ROC from 1912 to recent years. But it shall concentrate on diplomatic situations after 1949 when the ROC government moved to Taiwan. The ensuing topics shall include Taiwan' international status after the Korean war and San Francisco Peace Conference, withdrew from the UN, interruption of diplomacy with the USA, and adopting pragmatic foreign policy, southward policy.</p>
