<b>Course Introduction</b>	<p>This class (Political and Economic Development of the EU) is designed to deepen the understanding of multilateral cooperation, political and economic integration taking place on the international stage through the study of these processes within the European Union. It takes a historical perspective on the selected issues in the process of European integration.</p>
