Course Introduction	<p>Modern microeconomics is the study of the behavior and interactions among the various individuals and organizations within an economic system.</p> <p>Typically, microeconomics considers the forces that shape the behavior of such economic elements as consumers, producers, buyers, sellers, individuals, sole proprietors, partners, corporations, not-for-profit organizations and industries.</p> <p>These interactions are usually described as interactions within the context of markets.</p> <p>Microeconomics concerns any actor, including in the political science sector.</p>
