Course Introduction	<p>The course is designed to introduce the knowledge of interpretations and applications of CISG (United Nations Convention on Contracts for the International Sale of Goods), which governs the tangible goods in international trade. The course also emphasizes the practical skills to take different views from related parties in potential interpretations and applications. The students will be divided into groups to defend the assigned legal position in mock hearing in front of arbitration tribunal.</p>
