Course Introduction	<p>This course is the second half of the year-long Public International Law program. It aims to deepen students' understanding of the functions and underlying principles of public international law by exploring specific topics in greater detail throughout the semester. Key topics include the relationship between international law and municipal law, the recognition of states, territorial sovereignty, and jurisdiction. By the end of the course, students are expected to develop the ability to independently analyze and evaluate international relations issues through the lens of international law.</p>
