# The EU's Economic Policies Dr. Reinhard Biedermann

The course provides analysis of the economic rationale for the European Union economic policies, the political background and current state of affairs. It applies classical theoretical approaches of international relations theory as well as modern, regional analytical approaches or governance modes (like multi-level-governance, Europeanization, regulatory state, mutual recognition) on central issues and problems on European economic integration. Participants will gain profound insight on the role of European institutions (while not neglecting the Nation state) towards the single market program and its convergence, disparities and distribution effects within the EU. The EU's policy making will be illustrated on issues such as the Economic and Monetary Union, trade integration, common agricultural policy, competition and industrial policies, consumer and environmental protection, and the EU social and cohesion policy after the last enlargements. A resonate perspective during our debates will be the external effects of the EU's single market policies and the relevance for actors outside the EU, like individuals, corporations and countries.

- It is advised to parallel read an introduction on EU economic integration about the relevant issues
- Each participant must read and prepare the given or issued literature for the sessions
- Preparation of an oral presentation of approximately 25 minutes
- One written paper of about 15-20 pages
